- Processes of inclusion will be developed collaboratively with relevant services & agencies to identify community requirements and facilitate inclusive practices.
- We apply for Bi Cultural workers to support cultural and language inclusiveness within the centre.
- Our service will strive to foster and work towards a caring and compassionate community and greater society by applying the principles of access based on equity, participation and openness in the development and application of our centre policies.
- To provide support for all families by directing them to community services through the use of our Local Community Services Directory located in the foyer that may assist and support their child rearing practices within the local community.
- Formulate policies that are reflective of a broad based community and promotes inclusion of all within our community.
- Our educational program will recognise the value of parents, caregivers and staff
 working collaboratively to provide children with a wide view of the world and
 nurture and educate them holistically.
- Information nights for parents, social events organised through the centre and or activities as suggested by parents and caregivers that help to inform or support families in all there forms will be undertaken by our centre.
